Conducted over a thousand settlement conferences in a wide variety of litigation.

In criminal cases, presided over felony pretrial matters, including arraignment, bail and detention hearings, evidentiary hearings on motions to suppress; conducted criminal trials in misdemeanor and petty offense cases; accepted guilty pleas; issued search and arrest warrants; selected grand jury members and presided over matters affecting their service; accepted grand jury returns. Sentenced thousands of defendants in wildlife offense cases under the Migratory Bird Treaty Act and the National Wildlife Refuge Act.
